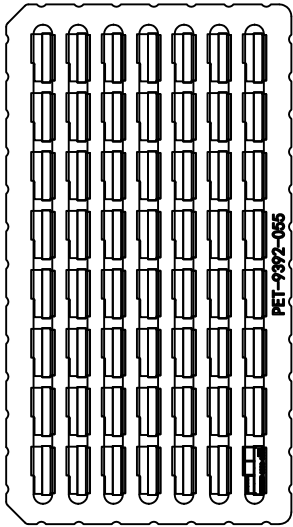

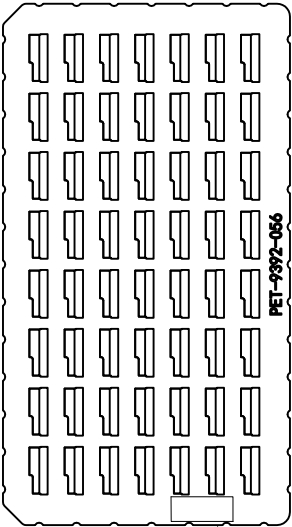

- 一.PET Plate Packing Mode:
(PET盤包裝方式)
- (1).CT-0.9 Box: PET-9392-055 xx PCS.
(CT-0.9規格的紙箱放PET-9392-055盤 xx PCS)
- (2).Put product in each trough fully as shown in diagram. such as Fig1-1.
(產品在盤子中擺放方式如圖1-1所示)
- (3).After filling each trough with product fully,cover it with transparent upper cover PET-9392-056 1PCS 。 the cover should be booked with the plate together, so as not to cause the products to fall scattered.
(每盤放滿產品後,加蓋透明上蓋 PET-9392-056 1PCS并在每個盤子上面加蓋子1PCS, 蓋子要與底盤訂在一起, 以免造成產品散落。)
- (4)The label of batch label is stuck on each cover
(such as Fig. 1).

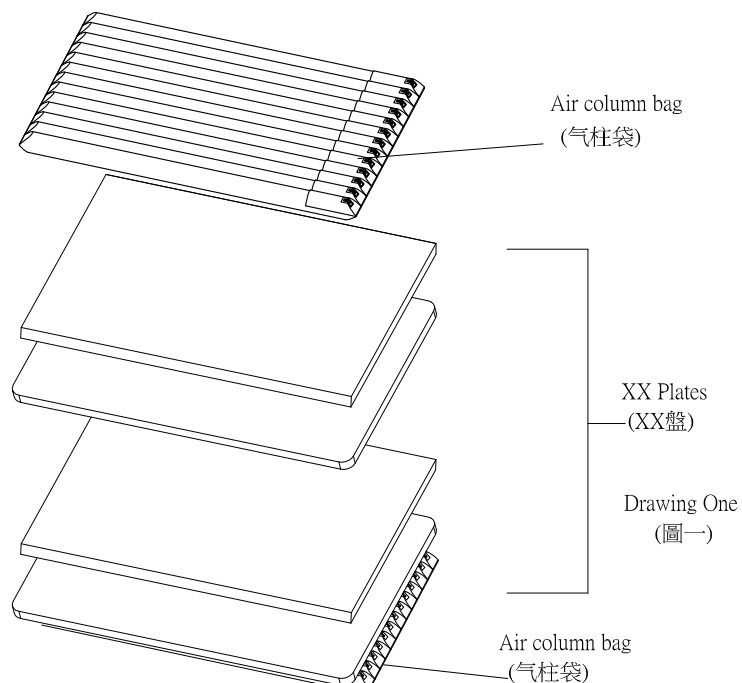

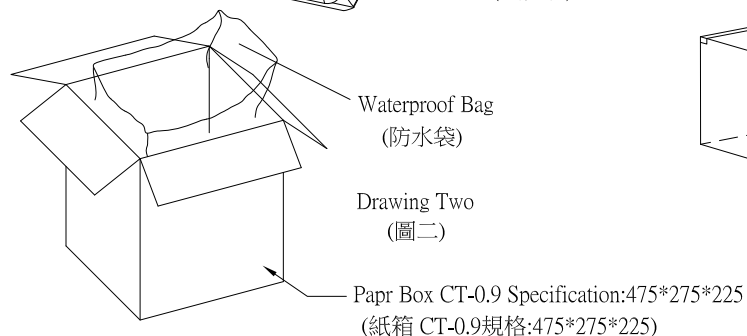

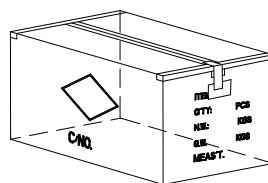

一.Outer Box Packing Mode:

(外箱包裝方式)

- (1).Paper box 0.9 standard 1 PCS,as shown in drawing Two.
(紙箱 0.9 規格 1 PCS.如(圖二)所示)
- (2).Put one Air column bag in the upper and lower of the paper box.,2PCS in all.,as shown in drawing One.
(每箱上下各放一塊气柱袋,共2PCS,如(圖一)所示)
- (3).Put 1 PCS waterproof in the paper box,as shown in drawing Two.
(紙箱內側放入防水袋 1 PCS.如(圖二)所示)
- (4).Piled the XX packing plates packed up in the waterproof.
(將放滿產品的XX個PET盤疊起,裝入防水袋內)
- (5).Seal the waterproof bag,then put the Air column bag 1PCS on the bag, if box can not be fullled ,filled with ploy.
(Put 1 PCS Air column bag at the right and left side in the paper box if it is necessary.)
